10. Breaching school security.

11. Possession of unauthorized devices and/or gazettes.

12. Any other act of gross indiscipline.

13. All major acts of indiscipline, which may have serious implications on the general body of students,

And/or which may warrant a uniform and more formalized nature of investigation, shall be handled by the Students Disciplinary Committee of this Institution.

14. Cases of adoption of unfair means in an examination.
